- Success stories were the live oak woodland saved east of Mokelumne Hill, which was a result of work done earlier, and maintained in 2015; and the shaded fuel break in Pine Acres, which helped save that area.

- EBMUD, Chris Swann
  - Mr. Swann explained that EBMUD sees its role as a partner, not a leader. One activity is helping volunteers spread straw mulch and spray psyllium tacking spray over it.
- BLM, Bill Haigh
  - Mr. Haigh has secured for BLM 3.5 million dollars to fund erosion control implementation on burned BLM properties. This will include aerial application of straw, and some wood chipping, mostly focused close to Ponderosa Road and the Jesus Maria Canyon.
- NRCS, Amy Rocha
  - Ms Rocha quickly reviewed best management practices (BMP) for erosion control. NRCS is currently processing 30 applications for EQIP grants to help fund private land owners erosion control efforts.
- CalAm Team, Jan Bray
  - Ms. Bray related that CalAm is working with Jeff Crovitz, Calaveras County Public Works Director, on grant applications to FEMA and CalOES for erosion control funding.
