 - Details regarding coordination of the signing event following the next meeting are discussed, and tasks assigned as follows:
 - Robin Wall will coordinate from USFS side including working with the Public Information Officers, including USFS Region 5; Katherine Evatt and Gwen Starret will coordinate from the ACCG and Upper Mokelumne River Watershed Authorit (UMRWA) side; the Admin Work Group will participate in a call to finalize plans. More explanation on how the MSA will work may be needed, and can be provided in the future.
- 7. Presentation: Smith's Grinding Operations Brian Mulholland
 - John Romena, Robert Smith, and Brian Mulholland have taken an old lumber mill site in Wallace, CA and turned it into a log yard. Using local contractors equipment, they have delivered 100 loads of wood chips so far. PG & E has been providing trees removed from their right of way in the Butte Fire, which has been crucial to making enough money to cover paychecks. Challenges currently being worked on include finding a way to accept homeowner's logs that are beetle killed or burned, without cost to the homeowner, acquiring a post and pull machine that can utilize short logs to make posts, and getting added to the region's economic development plan.

 - Funding individual's travel to the National Forest Foundation (NFF) Collaborative Restoration workshop in Denver is moving forward. John Heissenbuttel drafted the ACCG letter of support for this and submitted it to Teresa McClung and Rick Hopson.

- A field trip group went to the Darby Fire area, to see the Last Chance project, which includes approximately 400 acres of brush removal along the Utica ditch. It is a possible site for maintenance by grazing, since there are houses too close for using prescribed fire.
- A field trip group also went to the Mckay's project, and to a fuel break built for the Butte Fire. A challenge is how to maintain that fuel break, which is important to protecting the town of Avery.
- 10. Monitoring Work Group
 - The next monitoring meeting (May 4) will include a presentation by Mr. Metcalfe of USFS Region 5, which has done a socioeconomic study which includes West Point, Wilseyville, and Jackson.
 - Dennis Bowker suggests contacting Henry Provencio from Flagstaff AZ.
- 11. Tree Mortality Work Group
 - Amador and Calaveras are forming tree mortality task forces, and ACCG representatives are involved. Each county has two parts to their group a core group of mainly agencies, and a task force more open to the public. Alpine is not included as high risk yet.
 - ACCG may set up an area of the website with resources for people facing tree mortality issues on their property. Tuolumne County has an example. Disclaimer is needed.
- 12. Presentation: USFS Mokelumne Water Education Video Sherry Reckler and Steve Dunsky
 - Goal is a 60 second high resolution video that is compatible with social media, and with big screen. It will be available to partners as public domain work produced by USFS. Input is desired from locals who know about the region including ACCG participants, landowners. A key factor is tying it all the way down to the Bay Area, to show the connection.
 - Challenges include topography here, locating local resources, finding professional B-roll, and deciding on possible data to collect in the process.
