Owl Habitat Discussion with the Scottiago Forest Health Project

- Multiple PACs in this project.
- Most of the project area has been treated/thinned in the past since the 1990s.
- The tallest/high canopy trees are within PACs.
- Target is at least 50% campony cover where it exist in treatment units.
- 5,000-7,000 board feet/per acre of Commercial Harvest is expected.
- An estimate 1,800 acres are in HRC and about 300 acre of treatments in PACs.
