Start with the five steps Greg Suba proposed (in email to the Pyro Ad Hoc group, 10/21/2021):<ol style="list-style-type: none">1. Understand the landscape and subdivide it into strategically derived fire management areas (e.g., PODs, boxes, etc.)2. Agree on strategy for where, when, and how best to manage for fire within every containment area / box, and between containment areas / boxes.3. Identify which boxes are in most urgent need of work in order to apply, manage, and/or suppress fire effectively and as safely as possible.4. Seek and obtain funding for that work.5. Implement 1st-entry fire and/or thinning followed by fire as planned.• Amador and Calaveras Districts — are there updated PODs available for your forests?
