## ACCG Funding Coordination Work Group Action Items November 11, 2020

Meeting Brief:

- Michael Pickard provided an update on the SLAWG project inventory and prioritization tool as it related to identifying Category 1 (non-controversial) priority projects within the ACCG area.
- Richard Sykes shared about UMRWA's concept proposal to the Sierra Nevada Conservancy (SNC) for NEPA for National Forest system lands and possibly also Bureau of Land Management (BLM) lands within the ACCG focus area.
- The group discussed potential projects to seek funding for while the Planning WG's list of priority projects is under development.
  - Zac Croyle provided an overview of the Mattley Meadow project whose application to the Wildlife Conservation Board was not funded. Zac described ACCG consensus support for the project and provided the current status. The group discussed possible sources of funding and its strong interest in keeping an eye out for future suitable grant opportunities.
  - The group discussed the status of the projects recorded on the potential SNC stimulus funding list. Participants shared about the status of their respective projects.

    - Winton Fuel Break (planning).
    - Lost Horse aspen restoration (implementation).
    - Foster Firs aspen restoration (implementation).
    - View 88 grazing allotment fence repair/relocation (implementation).
    - Scottiago Project prescribed fire or biomass removal (implementation).
  - Carinna Robertson volunteered to serve as liaison between the Planning WG and Funding Coordination WG.
- The next meeting is set for Tuesday, December 8<sup>th</sup> from 3pm to 4pm and will cover possible emergency legislative budget changes, the updated SNC-project list, UMRWA's NEPA concept proposal, and available grant opportunities.
