**ACCG Pyrosilviculture Shared Vision**: continue discussions on defining broad plan for implementing pyrosilviculture shared vision. Proposed next steps from 2021 Pyrosilviculture Ad Hoc group discussion (Greg Suba, 10/21/2021):

1. Understand the landscape and subdivide it into strategically derived fire management areas (e.g., PODs, boxes, etc.)
2. Agree on strategy for where, when, and how best to manage for fire within every containment area / box, and between containment areas / boxes.
3. Identify which boxes are in most urgent need of work in order to apply, manage, and/or suppress fire effectively and as safely as possible.
4. Seek and obtain funding for that work.
5. Implement 1<sup>st</sup>-entry fire and/or thinning followed by fire as planned.
